551.083 Consider the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultations with representatives of employees groups

551.084 Excluding witnesses from a hearing

Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or session, then the final vote shall be either:

(a) in the open meeting covered by the Notice upon reconvening of the public meeting; or

(b) at a subsequent public meeting of the School Board upon notice thereof:
